


Q6. The Regional Executive Committee provide clear and consistent strategic direction










Q6. The Regional Executive Committee provide clear and consistent strategic direction










Q8. The Governing Council has the range of expertise it requires to fulfil its responsibilities










Q9. The IPPF governance structure (regional and global) gives enough voice to the Member Associations










Q9. The IPPF governance structure (regional and global) gives enough voice to the Member Associations






Q10. The IPPF governance structure (regional and global) ensures the most capable individuals rise to the top of IPPF's decision-making bodies










Q10. The IPPF governance structure (regional and global) ensures the most capable individuals rise to the top of IPPF's decision-making bodies






Q13. How much of your annual income do you receive via IPPF (both restricted and unrestricted)?






Q14. How much of your unrestricted funding do you receive via IPPF?










Q16. The current Resource Allocation model serves the wider Federation perspective well.










Q16. The current Resource Allocation model serves the wider Federation perspective well.








Q18. The current Resource Allocation model is transparent (I know how and why decisions are made about the allocation)










Q19. What do you see as the most important criteria for allocating IPPF core funding?






Q20. All Member Associations should receive unrestricted funding?








